

Terms and conditions for filming and photography at Zurich Airport

- Airport operations and passenger flows must not be obstructed in any way.
- No areas may be closed off.
- Passport and security checks as well as security personnel may not be filmed or photographed.
- The applicant undertakes to observe the Data Protection Act.
- For filming/photography of employees, their permission and that of the airport partners must be obtained.
- For filming/photography in a shop, restaurant or any other business, permission must be obtained in advance from the operator.
- For filming/photography at a gate or check-in counter, permission must be obtained in advance from both the handling agent and the airline.
- Filming/photography of SWISS or Edelweiss aircraft that were not commissioned by these companies and are recognizable as such in the images may only be used for private purposes. Additional authorization from the airline is required for commercial purposes.
- Zurich Airport must be recognizable in the film/on the photographs. No other airport logos may be used and the infrastructure must not be misrepresented or changed.
- No infrastructure (e.g. signaletics, advertising screens, clocks, posters, etc.) belonging to Flughafen Zürich AG and its partners may be covered, taped over or recorded over.
- The location must be left as it was found (if poster stands, waste garbage cans etc. are moved, everything must be put back as it was). Please do not leave any garbage or similar behind.
- Escape routes and emergency exits must be always free and accessible.
- Equipment or personal items must never be left unattended.
- Additional services such as electrical installations, scaffolding, barriers, cleaning, parking, etc. will be charged at cost.
- No duty-free goods may be purchased in the non-public zone.
- While in the non-public zone of the airport, every participant must wear an official badge.
- For filming/photography in the non-public, the registered group must always stay together. It is therefore not possible to split up the group.
- For filming/photography in the Circle Park, the park regulations must be adhered to.
- In the event of scheduling conflicts, special occurrences or security concerns, filming/photography maybe cancelled at short notice without compensation.
- The applicant is liable for all direct or indirect damage incurred to Flughafen Zürich AG and its employees in connection with filming/photography carried out by the applicant.
- The applicant will not hold Flughafen Zürich AG liable for any claims for damages by third parties made against Flughafen Zürich AG in connection with filming/photography.
- Flughafen Zürich AG is entitled to view all films/photographs before they are made public. If the films/photographs do not correspond to the purpose indicated or the applicant refuses to allow the films/photographs to be inspected, Flughafen Zürich AG is entitled to prohibit the use of the films/photographs. Flughafen Zürich AG also reserves the express right to claim compensation.
- The instructions of Flughafen Zürich AG must be adhered to at all times.

Rates for filming and photography at Zurich Airport

General information

Charges apply to filming/photography in all areas of Zurich Airport carried out for commercial or advertising purposes, including cinema and TV films, as well as for corporate image brochures and annual reports.

Charges do not apply to filming/photography intended to provide the general public with news or current affairs.

All rates include VAT.
